

Mercer Special Hockey Children's Privacy Statement

These web sites (these "Sites") are owned and operated by Mercer Special Hockey ("we" or "us" or "our").

This Children's Privacy Statement. This Children's Privacy Statement describes our current policies and practices with regard to the personal information we collect on these Sites about individuals that we know are children under the age of 13 or in areas of these Sites that are directed to children under the age of 13. With respect to other personal information collected through these Sites, please see our general [Privacy Statement](#). For purposes of this Children's Privacy Statement, the terms child and children mean individuals under the age of 13 and the term personal information means individually identifiable information about a child collected on these Sites about that child. The term parent means parent or legal guardian.

This Children's Privacy Statement was last revised on October 1, 2011.

What Personal Information Do We Collect Through These Sites?

To participate in some of our online activities, we ask users to provide certain personal information, such as their name, age, gender, e-mail address, mailing address, telephone number, parent's e-mail address and preferences. These online activities include e-mail newsletters, scheduling practices/games/tournaments, Mercer Special Hockey story submissions, question/comment submissions and surveys. However, we do not condition a child's participation in an activity on the child's disclosing more personal information than is reasonably necessary to participate in that activity.

Do We Use Personal Information Collected Through These Sites?

We use personal information collected from children to provide the information, offerings and services requested by these children, such as to send e-mail newsletters or to inform Mercer Special Hockey Members, including those under age 13, about Mercer Special Hockey games, practices, tournaments and activities. We also use personal information collected from children to improve the content and functionality of these Sites, to better understand our visitors and members, to improve our offerings and services, and to market our events, offerings and services to children or their parents. In addition, we use personal information to contact children or their parents with offers and information about events, offerings and services from other organizations we believe will be of interest to the children or their parents.

Do We Share Personal Information Collected Through These Sites?

Except as described in this Privacy Statement, we do not share with third parties personal information that we collect on these Sites about individuals that we know are under the age of 13, unless we have received prior parental consent. We give parents the option of consenting to our collection and use of their child's personal information without consenting to our sharing that personal information with third parties. Subject to the foregoing, we share personal information collected online through these Sites with our affiliated organizations (such as other hockey associations, leagues or teams) and other organizations that are part of our affiliates, who may use this information in ways similar to how we use this information.

In addition, there may be some other, limited circumstances in which we may share or transfer personal information in our databases to a third party, for example, to comply with a legal requirement, for the administration of justice, to protect the security of our systems or service, or in the event of a merger, reorganization, dissolution or similar event.

We do not share, distribute or publish personal information collected from parents/players with any other parties, unless already noted in this section, without your express consent in advance.

How Can Parents Review Information Collected From Their Child?

Parents may review the personal information that we have collected from their children online, prevent the further use or collection of such information and request that we delete such information by filling out and mailing or emailing us the requested changes or deletions. Certain information provided by parents about children is necessary to participate in Mercer Special Hockey and may not be deleted without removing the children from the active roster of Mercer Special Hockey.

Do These Sites Use Cookies?

These Sites use certain software technology known as cookies. Cookies are small text files that a web site places on a visitor's computer browser to store certain information about the visitor, such as a visitor's preferences. Cookies themselves do not necessarily contain personal information; however, cookies could be used to enable a web site to link a visitor's use of the web site with personal information provided by a visitor. We do not link cookies with a visitor's personal information. Some web browsers provide you with the ability to turn off or refuse cookies. However, if you turn off or refuse cookies, some of the features of these Sites may not function properly.

Links to Other Web Sites.

This Children's Privacy Statement applies only to our Sites. Our Sites contain links to other web sites. These other web sites have their own policies regarding privacy. We urge you to review the privacy policy posted on any site you visit before using the site or providing any personal information about yourself. In addition, you may have linked to these Sites through another site. For example, in certain cases you may have linked to these Sites through banner advertising on another site. In such cases, the site you linked from may collect information from people who click on the banner or link. You may want to refer to the privacy policies on those sites to see how they collect and use this information.
